



## SIBA Members' Survey 2023/24 Prize Draw – Terms & Conditions



### 1. THE PROMOTER

1.1 The promoter of this prize draw is: The Society of Independent Brewers, SIBA, PO Box 136, Ripon, North Yorkshire HG4 5WW ("SIBA").

### 2. THE DRAW

2.1 The title of the prize draw is "SIBA Members' Survey 2023/24 Prize Draw".

### 3. HOW TO ENTER

3.1 The prize draw is free to enter and no purchase is necessary.

3.2 To enter the competition you must:

- (a) Fully complete the SIBA Members' Survey 2023/24 at <https://www.surveymonkey.co.uk/r/SIBA2023-24>
- (b) submit your brewery production figures via the Toolbox or direct to [membership@siba.co.uk](mailto:membership@siba.co.uk) no later than 28.02.24
- (c) tick the box to confirm you wish to enter the prize draw; and
- (d) enter your contact information.

3.3 Only one entry per brewery member is permitted and the last complete survey response submitted will be treated as the final version.

3.4 The prize draw will include eligible entries received from 10.11.23 until 31.01.24 (the "**Closing Date**") and will be drawn at random on the 01.03.24. SIBA reserve the right to change these dates without written notice to entrants.

3.5 SIBA will **Not** accept:

- (a) responsibility for entries that are lost, regardless of cause, including, for example, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
- (b) proof of submission or transmission as proof of receipt of entry to the prize draw.

3.6 By submitting an entry, you are acknowledging that you have read, accept and agree to be bound by these terms and conditions.

3.7 One entry will be chosen from all of the entries received once any duplicate entries are removed. The winner will be selected by random draw supervised by an independent person on the first working day after the Closing date ("**Draw Date**") and will win the prize (as specified in condition 5.1).

3.8 By entering the prize draw, you hereby warrant that all information submitted by you in your entry is true, accurate and complete in every respect. SIBA reserves the right to verify any information contained in your entry and/or your eligibility to enter the prize draw.

3.9 SIBA reserves the right in its absolute discretion to disqualify any entrant if it has reasonable grounds to believe that an entrant has breached any of these terms and conditions, any applicable law. Each entrant acknowledges and agrees that any failure to comply with these terms and conditions could lead to SIBA disqualifying that person, without SIBA giving any reason for such disqualification or granting any opportunity for challenge.

3.10 In the event that a prize-winner is disqualified from the prize draw, SIBA will select an alternative prize-winner in the same manner as the original prize-winner and such selection will be subject to these terms and conditions.

### 4. ELIGIBILITY

4.1 The prize draw is only open to SIBA Brewing Members

4.2 Any person that :

- (a) is a paid employee of SIBA or its holding or subsidiary companies;
- (b) is an employee of agents or suppliers of SIBA or SIBA Commercial Services, who are professionally connected with the prize draw or its administration;
- (c) is a member of the immediate families or households of (a) or (b)

is not eligible to enter the prize draw. SIBA reserves the right to disqualify any person that it knows is, or has reasonable grounds to believe is, ineligible for the prize draw as a result of this condition.

4.3 In entering the prize draw, you confirm that you are eligible to do so and eligible to claim the prize. SIBA may require you to provide proof that you are eligible to enter the prize draw.

4.4 SIBA will not accept entries that are:

- (a) automatically generated by computer;
- (b) completed by third parties or in bulk;
- (c) illegible, have been altered, reconstructed, forged or tampered with; or
- (d) incomplete.

4.5 There is a limit of one entry per brewery. In the event that SIBA discovers or has reasonable grounds to believe that the same person has made multiple entries, such person and any entries made by them shall be disqualified and, if such entrant has already been selected as a prize-winner, an alternative prize-winner will be selected in accordance with the process described above.

### 5. THE PRIZE

5.1 The prize is £500 Credit voucher with a SIBA Supplier Associate member of your choice

5.2 The prize must to be redeemed before 01.09.24

5.3 The prize is supplied by SIBA. SIBA reserves the right to replace the prize with an alternative prize of equal or greater value if circumstances beyond SIBA's control make it necessary to do so.

5.4 Prizes are subject to availability. There is no cash alternative for the prize. The prize is not negotiable or transferable.

5.5 In order to claim the prize you must comply with condition [7](#).

### 6. WINNER ANNOUNCEMENT

6.1 SIBA will announce the winner at the Chairman's Reception, held at BeerX on Wednesday 13<sup>th</sup> March 2024

6.2 The decision of SIBA regarding any aspect of this prize draw is final and no correspondence or discussion will be entered into.

6.3 SIBA will send the name and county of the winner to anyone who writes within 4 weeks after the Closing Date of that calendar month requesting details of the winner and who encloses a self-addressed envelope to the address set out in condition 1.1.

### **7. CLAIMING THE PRIZE**

7.1 If you are the winner of the prize, you must claim the prize by responding to SIBA within 14 days to the email sent to you in connection with condition 6.1. In your reply you must tell us your contact details, including your name, telephone number, email and postal address.

7.2 SIBA will make all reasonable efforts to contact the winner if not in attendance at BeerX. If the winner cannot be contacted or is not available, or has not claimed his/her prize within the time frame specified in condition 7.1 SIBA reserves the right to select an alternative winner in accordance with the process described above.

7.3 SIBA does not accept any responsibility if you are not able to take up the prize.

7.4 No prize will be awarded where any entrant has committed any form of misconduct (as determined by SIBA in its sole discretion).

### **8. LIMITATION OF LIABILITY**

In so far as is permitted by law, SIBA, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, disappointment, personal injury or death occurring as a result of any entrant entering this prize draw, taking up the prize, or as a result of any entrant winning or not winning any prize, except where it is caused by the negligence of SIBA, its agents or distributors or that of their employees. Your statutory right are not affected.

### **9. DATA PROTECTION AND PUBLICITY**

By entering into the prize draw you acknowledge and agree to the processing of your personal data in accordance with SIBA's data protection policy.

10.3 SIBA reserves the right to hold void, suspend, cancel, or amend all or any part of the prize draw where it becomes necessary to do so. Any changes to these terms and conditions, or cancellation of the draw, will be posted on the Website. It is the responsibility of entrants to keep themselves informed as to any changes to the terms and conditions.
